When a Child Dies: Research & Support

The Center was pleased to present the conference When a Child Dies: Research & Support to commemorate its 30th anniversary. The conference was attended by about 300 participants, including many parents, and was offered at no charge. The morning session concentrated on research. Henry Krous, MD, Director, San Diego SIDS/SUDC Research Project, presented current findings on Sudden Unexpected Death in Childhood (SUDC). He drew similarities between SUDC and SIDS, and also described California's system for classifying SIDS. Mary Anne Brizzi, parent and Advisory Board Chair, introduced Dr. Krous. Dr. Krous was followed by a panel of researchers: Rachel Moon, MD, Medical Director, Children's Health Center, Children's National Medical Center; Ling Li, MD, OCME and Assistant Professor, University of Maryland School of Medicine; and H. Ronald Zielke, MD, Professor and Chief, Division of Pediatrics, University of Maryland School of Medicine. Dr. Moon has done extensive research in SIDS, particularly related to daycare, and presented her research. Also, she was instrumental in the change in Maryland's daycare regulations requiring all infants be placed on their backs to sleep and all daycare providers to have "SIDS" training. Dr. Li presented findings from her study that looked at sleep position among infant deaths. This study was funded. in part, by the Center. Dr. Zelke, discussed the tissue bank and associated data. The panel was moderated by Jodi Shaefer, RN, PhD, former Director of the Center.

After a buffet lunch, Ronald Gutberlet, MD, Director, Department of Pediatrics, Mercy Medical Center,

and Advisory Board Member, was recognized for his role in establishing the Center and his continued involvement during the past 30 years. Jonathan Melnick, SIDS sibling and Advisory Board Member made the presentation. The conference resumed with a focus on bereavement. Tom Golden, LCSW, author and clinician, presented findings from his book, Swallowed by A Snake. His presentation dealt with male grief and the roles of both sexes in the grieving process. Mr. Golden was followed by a panel discussion of services to families. Angela Burden, RN, MA, Director, CCP, Healthcare Access, moderated the panel and presented the role of the public health nurse in assisting families through the grieving process. Mary Ann Brizzi described her experience as a parent of a deceased child. Rev. David Harness, M.Div., BCC, Pastoral Care, University of Maryland Medical Center, discussed the role of pastoral care in the grief process. Mary LeSueur, BSW, Bereavement Coordinator, Center for Infant & Child Loss gave a brief overview of the Center and presented its role for families.

Feedback indicates the conference was well received and met many of the participants' needs for information. Thank you to those who contributed to this effort – your support always ensures success.

Counselors Corner: Grief-What to Say and What NOT to Say

few weeks ago, someone asked me to come up with a list of things to say and things to avoid saving to a newly bereaved person. Although much of it seems like common sense, it was a much more difficult task than I had originally thought. It's so difficult to know how to treat someone who has recently lost a child. It's scary and tragic. Many people avoid saying anything for fear of saying the wrong thing.

I came up with a list and welcome any additions from you. Maybe, after you read it, you can give it to someone who needs to know. Maybe it will start a dialogue in your own house. Please feel free to call me if you have suggestions.

What Helps:

- I'm sorry
- I don't know what to say
- I don't know how you feel but I want to try to help you if I can
- This must be so hard for you. I can't imagine what you are feeling
- It isn't fair
- Take all the time that you need
- I don't know why it happened
- I'm so sad for you
- I understand that you are angry
- I understand that you are hurt
- I understand that you feel guilty
- It's ok to cry
- What do you need right now?

What Doesn't Help:

- I know how you feel
- He's in a better place
- You need to move on, get on with your life
- You need closure
- She is with God now
- God needed him more than you did
- Things happen for a reason
- She will no longer be in pain
- You are so strong
- Count your blessings
- Luckily, you have other children
- Don't cry
- You shouldn't feel like that \(\cdot \)

o you really want to know what it's like to go through the experience of Sudden Infant Death Syndrome? Think of your worst dream ever coming to a reality... you wake up in a cold sweat, and in tears from the worst dream you ever had, but this time you didn't wake up. it's your reality. Your heart is pounding out of your chest, you're sweating and screaming, and yet this time you have this

nightmare to face in the real world where everyone around you is in their own life and nobody stops, but for a moment to lend a hand or give a kind word. Sometimes, a not so kind word... "so, what do you do from here?"

You are now a forever, changed person. You are now parents who have lost a child. Who are you now in all of this? Where do you go from here? Every parent handles this situation different,

some of the reality of what had happened to me in one full dose. Some withdraw, others keep busy so they don't have to think. I kept so busy that I don't think I sat down for the first 5 months after Tv died.

It has been a year now since that sad day, and if I allow myself to think about it deeply, I cry just as hard as the day it happened. The pain doesn't subside, you just learn to live with the reality of – you are now a parent who has lost a child. I find myself wanting to reach out to others now, where before I wanted nothing to do with helping. It was my problem and I didn't want to hear anybody else's problem, when I couldn't even handle my own.

Now I think about how I was in the beginning of all this...disbelief, fear, denial, anger...it was just too much. Now I have bouts of disbelief, but I have learned that it is in fact

my reality, so what now? I think about all those who are going through what I went through, wow, what I went through... I can handle this now, but I couldn't then. Now I must reach out to others who feel like they can't handle this and tell them that they can and that it will get easier. I want to tell them that the pain is so real and it's ok to feel it, but to know when to get up and move so that is doesn't take over them. I

have this need to reach out and help.

I had a counselor named Diane. She her soul, who was so gentle and kind. She went through the loss of her anyone who has lost a child. There are knowing someone is there for you and

was absolutely wonderful, God bless daughter years previous to now, and understood the depth of a loss like no answers to any of this, just truly understands, can be enough sometimes. Other times you want

answers and you have this need to know why this happened to you. What did you do so wrong to deserve this – NOTHING! You did nothing; it wasn't you or anything you had done. You have to believe this in order to go on and become focused again. Depression, without a doubt will happen, but there is a light at the end of all this. I know how hard it seems, I know that you could just lay down and never get up again. I know how much pain is in your heart and head and soul, believe me, I know...you will be ok. You will be a better person after all this is said and done, you will be able to help someone else when you start to heal. This I know, because I was where you are and I couldn't do this, but I made it here and so will you.

Scholarship used for ...

The Center was delighted that Mary Rose Custer, RN, Bereavement Coordinator, Peninsula Regional Medical Center, was able to make use of the Ronald L. Gutberlet Conference Scholarship Fund to attend the ASIP, (Associated SIDS and Infant Mortality Professionals) conference. Mary Rose submitted:

The seventeenth annual ASIP conference was held at the Westin Grand Hotel in Washington, DC on March 3rd, 4th and 5th. The pre-conference workshop included sessions on The National Increase in Pre-term Birth and Orientation to Child Death Review. The Virginia Institute of Forensic Science and Medicine sponsored the welcome reception on the Promenade level. The next two days of the conference were packed with information beginning with Marion Willinger's coverage on SIDS and Infant Mortality Research: Pathways to Discovery and Risk Reduction. Her review of the history of SIDS was informative, and laid good ground work for those new to the subject. Dr. Willinger shared that since 1970 the overall infant mortality rate has decreased by 65% and that the SIDS rate has decreased by 50%, proving that all the research and hard work is worth it.

Rachel Moon, MD presented the challenges the American Academy of Pediatrics (APP) task force faces in working with SIDS risk reduction issues. Every five years the AAP will review their recommendations on everything from apnea monitors and bed sharing to pacifiers and positioning in the hospital setting and either reaffirm, revise or retire their

statements. On the closing day of the conference a panel of forensic pathologists spoke on how they approach the diagnosis of SUIDS or "Sorely Under-Investigated Deaths" The moderator, Tom Andrew, added a lot of humor to the presentation, which was welcomed after three days of reviewing such intense information. The panel, being well diversified, educated the attendees on the challenges each face as they investigate a SIDS or SUID. Space does not allow me to comment on everyone that spoke; but I will say that ASIP and all of the presenters did an outstanding job!




